1.1 PROJECT INFORMATION

- A. Notice to Bidders: Qualified bidders may submit bids for project as described in this Document. Submit bids according to the Instructions to Bidders.
  - 1. Regulatory Requirements: Applicable laws and regulation of those having jurisdiction in the State of Illinois shall govern submittal, opening, and award of bids.
  - 2. All Contracts for the Construction of Public Works are subject to the Illinois Prevailing Wage Act (820 ILCS 130/1-12).
- B. Project Identification: 2023 MECHANICAL SYSTEMS IMPROVEMENTS – PRE-PURCHASE

Project Description: Project consists of, but not necessarily limited to, the pre-purchase of manufactured mechanical Unit Ventilators (UV) and Air Cooled Condensing Units (ACU) associated materials and accessories as identified in the Contract Documents, and delivery to second party contractors for installation under subsequent contracts over two consecutive years.
- F. Construction Contract: Bids will be received for a Single Prime Contract.

1.2 BID SUBMITTAL AND OPENING

- A. Owner will receive lump sum bids until the bid time and date at the location given below. The sealed bid must be submitted on the Bid Form provided, Project Name, Date and Time of Bid clearly marked on the outside of the sealed envelope to prevent premature opening. Owner will consider bids prepared in compliance with the Instructions to Bidders, and delivered as follows:
  - 1. Bid Date: 11 October 2022.
  - 2. Bid Time: 10:00 a.m. local time.
  - 3. Location: Streator Township High School District 40, 202 W. Lincoln Avenue, Streator, Illinois, 61364.
- B. Mechanical equipment submittals are to be included with the bid.**
  - 1. Equipment submittal to include manufacturer's product data and literature, warranty information, size and configuration of unit, and mounting weights.
- C. Anticipated date of equipment delivery is to be included with the bid.
- D. Bids will be thereafter publicly opened and read aloud.
- E. Any bid submitted unsigned, without bid bond or received subsequent to the aforementioned date and hour will be disqualified and returned to the bidder.

- F. Owner reserves the right to reject any and all bids and to waive informalities and irregularities.

### 1.3 BID SECURITY

- A. Bid Security is required in the form of a Bid Bond, AIA Document A310-2010 in an amount equal to not less than ten percent (10%) of the Base Bid and all Additive Alternates.
- B. It is the Owner's intent to issue a Notice of Award to the successful Bidder within thirty (30) calendar days of the Bid Date. No bid shall be withdrawn for a period of sixty (60) calendar days after the opening of bids.

### 1.4 DOCUMENTS

- B. Bid forms are included in the bidding documents and can also be downloaded separately from the BHFX website.

### 1.5 TIME OF COMPLETION

- A. Successful bidder shall begin the Work on receipt of the Notice to Award and shall complete the Work within the Contract Time. Date and time of pre-purchase equipment deliver shall be coordinated with the installing contractor. Work of this Contract is subject to liquidated damages.

### 1.6 BIDDER'S QUALIFICATIONS

- A. Bidders must be properly licensed under the laws governing their respective trades and be able to obtain insurance and bonds required for the Work.
- B. The successful bidder will be required to furnish a Performance Bond and a Payment Bond, in the amount of one hundred percent (100%) of the contract sum, on AIA Document A312-2010, as issued by the American Institute of Architects.
