1.1 PROJECT INFORMATION

- A. Notice to Bidders: Qualified bidders may submit bids for project as described in this Document. Submit bids according to the Instructions to Bidders.
  - 1. Regulatory Requirements: Applicable laws and regulation of those having jurisdiction in the State of Illinois shall govern submittal, opening, and award of bids.
  - 2. All Contracts for the Construction of Public Works are subject to the Illinois Prevailing Wage Act (820 Illinois ICS 130/1-12).

- E. Project Description: Project consists of the of the replacement and the repair of various roof areas. The Work has been split into base bid and alternates by the areas below and in the attached Section 004113.1 Bid Contract Plan.
  - 1. Base Bid: Reroof of Roof Areas 1, 9, 32, 33A, 33B
  - 2. Alternates A - F: Repair of Roof Areas 4, 8, 10, 31A, 31B and 31C.
  - 3. Alternate G: Sheet metal wall panels at Roof Area 4
- F. Construction Contract: Bids will be received for the Work:
  - 1. To be constructed under a single prime contract based on a Stipulated Price, as described in the Contract Documents, at the discretion of the Owner.

1.2 BID SUBMITTAL AND OPENING

- A. Owner will receive lump sum bids until the bid time and date at the location given below. The sealed bid must be submitted on the Bid Form provided, Project Name, Date, Time of Bid and "ATTN: Bryan Arnold" clearly marked on the outside of the sealed envelope to prevent premature opening. Owner will consider bids prepared in compliance with the Instructions to Bidders, and delivered as follows:

  - 2. Bid Time: 1:00 p.m., local time.
  - 3. Location: North Chicago Community High School, 1717 17th Street, North Chicago, Illinois 60064
- B. Bidders will not be permitted to attend the bid opening in person; bidders may attend by video or telephone call in.

- C. Bids will be thereafter be opened and read aloud.
- D. Any bid submitted unsealed, or unsigned, without bid bond or received subsequent to the aforementioned date and hour will be disqualified and returned to the bidder.
- E. Owner reserves the right to reject any and all bids and to waive informalities and irregularities.

### 1.3 BID SECURITY

- A. Bid Security is required in the form of a Bid Bond, AIA Document A310 in an amount equal to not less than ten percent (10%) of the Base Bid and all Additive Alternates.
- B. It is the Owner's intent to issue a Notice of Award to the successful Bidder within sixty (60) calendar days of the Bid Date. No bid shall be withdrawn for a period of ninety (90) calendar days after the opening of bids.

### 1.4 PREBID MEETING

- A. Prebid Meeting: A mandatory in-person / virtual prebid meeting for all bidders will be held as follows. Prospective bidders are required to attend. Failure to attend will result in rejection of bid.
  - 1. Meeting Date: 17 November 2020.
  - 2. Meeting Time: 1:00 p.m., local time.
  - 3. Location: North Chicago Community High School, 1717 17th Street, North Chicago, Illinois 60064.

A. Successful bidder shall begin the Work on receipt of the Notice of Award and shall complete the Work within the Contract Time. Work is subject to liquidated damages.

1.7 BIDDER'S QUALIFICATIONS

A. Bidders must be properly licensed under the laws governing their respective trades and be able to obtain insurance and bonds required for the Work.

B. The successful bidder will be required to furnish a Performance Bond and a Payment Bond, in the amount of one hundred percent (100%) of the contract sum, on AIA Document A312, as issued by the American Institute of Architects.
