1.1 PROJECT INFORMATION

- A. Notice to Bidders: Qualified bidders may submit bids for project as described in this Document. Submit bids according to the Instructions to Bidders. Regulatory Requirements: (105 ILCS 230/) School Construction Law shall govern submittal, opening, and award of bids.

1.2 BID SUBMITTAL AND OPENING

- A. Owner will receive sealed lump sum bids until the bid time and date at the location given below. The sealed bid must be submitted on the Bid Form provided, Project Name, Date and Time of Bid clearly marked on the outside of the sealed envelope to prevent premature opening. Owner will consider bids prepared in compliance with the Instructions to Bidders issued by Owner, and delivered as follows:
 - 1. Bid Date: 12 May 2021
 - 2. Bid Time: 1:00 p.m. local time.
 - 3. Bids must be addressed to: Dr. Brian O'Keeffe – Assistant Superintendent of Finance/CSBO.
 - 4. Location: District Administration Office, Arbor Park School District 145, 17301 Central Avenue, Oak Forest, Illinois 60452
- B. Bids will be thereafter publicly opened and read aloud. Bidders will not be permitted to attend the bid opening. Virtual meeting information will be issued by addendum.
- C. Any bid submitted unsealed, or unsigned, without bid bond or received subsequent to the aforementioned date and hour will be disqualified and returned to the bidder.

1.3 BID SECURITY

- A. Bid security shall be submitted with bid in the amount of 10 (ten) percent of the bid amount. No bids may be withdrawn for a period of 60 (sixty) days after opening of bids. Owner reserves the right to reject any and all bids and to waive informalities and irregularities. Form of Bond shall be AIA Document 310.

1.4 SITE VISITS

- A. Mandatory site visits: Visits to the site can be arranged by emailing the Owner's representative by email minimum 1 day prior to visit. Bidders are required to visit the site and familiarize themselves with the conditions under which the work is to be performed.
- B. Bidders' Questions: Contractors to submit bidding questions to Architect's representative via email. Architect will provide responses to bidder's questions no later than 4 days prior to bid opening. Bidding questions shall be submitted to Architect's Representative via email. Any questions received later than 4 days prior to bid opening shall not be answered.

1.5 DOCUMENTS

1.6 TIME OF COMPLETION

- A. Successful bidder shall begin the Work on receipt of the Notice to Proceed and shall complete the Work within the Contract Time.

1.7 BIDDER'S QUALIFICATIONS

- A. Bidders must be properly licensed under the laws governing their respective trades and be able to obtain insurance and bonds required for the Work.
- B. The successful bidder will be required to furnish a Performance Bond and a Payment Bond, in the amount of one hundred percent (100%) of the contract sum, on AIA Document A312, as issued by the American Institute of Architects.
